Kokrajhar, Assam, Pin - 783370 for Pre-service Teacher Education (PSTE) Course of two years duration from the academic session 2004-2005 with an annual intake of 100 (one hundred) students subject to fulfillment of the following:
 - That the institution will ensure that Principal and at least 10 (ten) faculty members duly approved by the affiliating body are in position for an a) intake of 100 students.
 - The institution shall comply with the various other norms and standards b) prescribed in the NCTE regulations.
- 4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, the State Government etc.
- 5. The institution shall submit to the Regional Committee a Performance Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating body to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.
